Reforms

- One national scheme
- National Boards 10+4 health profession
 - From 85 Boards
- Acts of Parliament in each State and Territory
 - From 61 Acts
- Australian Health Practitioner Regulation National Law
 - Establishes the national regulation and accreditation scheme

Public Register ...

- All registrants
- Type of registration general, provisional, limited, specialist
- Conditions, reprimands
- Suspended, cancelled
- Panel decisions de-identified
- Tribunal decisions



Board Functions ...

- Registration
 - register suitably qualified and competent person
 - requirements for registration or endorsement including supervised practice
 - register and impose conditions
- Standards, codes and guidelines
 - accreditation standards developed and submitted to it by an accreditation authority
 - registration standards for approval by the Ministerial Council
- Notification
 - oversee receipt, assessment and investigation,
 - monitoring conditions, undertaking and suspensions
- Establish panels to conduct hearings
 - health and performance and professional standards
 - health matters for registered students
- Refer matters to a Tribunal

Notifications ...

Guiding Principle

- Restrictions on the practice of a health profession are to be imposed only if it is necessary to ensure health services are provided safely and are of an appropriate quality
- Mandatory and Voluntary
- Relationship with Health Complaints Entities

Mandatory notifications...

- Notifiable conduct
 - practising while intoxicated by drugs or alcohol
 - engaging in sexual misconduct in professional practice
 - placing the public at risk of substantial harm through a physical or mental impairment affecting practice
 - placing the public at risk of harm through a substantial departure from accepted professional standards
- Practitioners and employers must report registrant who they believe has engaged in notifiable conduct (some exceptions)
- Belief formed through the practice of the profession

Voluntary Notifications ...

- Unprofessional conduct lesser standard
- Performance knowledge skill or judgement below standard
- Professional misconduct
 - substantially below,
 - more than one instance of unprofessional conduct,
- personal or professional behaviour where not a fit and proper person.
- Impairment health practitioners and students



Unprofessional conduct

Includes

- providing a person with health services that are excessive, unnecessary or otherwise not reasonably required for the person's well-being
- accepting a benefit as inducement, consideration or reward for referring another person to a health service provider or recommending another person use or consult with a health service provider
- giving or receiving a benefit for a referral where the practitioner has a pecuniary interest unless the interest is disclosed

The Notifications Process ...

- Preliminary assessment
- Option to take immediate action or no further action
- Investigation
- Board and practitioner may enter an undertaking
- Board may caution, reprimand, impose conditions
- Refer to a Panel or Tribunal

Panels ...

- Performance, standards & conduct
- Impairment
- Outcomes
 - Caution
 - Reprimand on public register
 - Conditions on public register

De identified published record of panel decisions



Tribunals ...

- Appeals from decisions of Boards about registration and notifications
- Decision makers at first instance
 - Professional misconduct
 - Registration obtained by fraud
- Powers
 - Caution or reprimand
 - Impose conditions
 - Fine
 - Suspend
 - Cancel



AHPRA and the Health Complaints Entities

- Notify each other of notifications (complaints)
- Exchange information
- Reach an agreement who to take action
- If cannot agree then most serious form of action
- AHPRA has an MOU with the HCEs

Privacy in National Law ...

- Incorporates Privacy Act 1988 (Cth)
- Collection Use and Disclosure Personal Information
- National Privacy Principles apply
- Collection for a primary purpose
- Disclosed for a secondary purpose and other reasons under the NPPs
- National Law allows exchange of information to Medicare, Immigration and other similar entities



ACCC/TGA/AHPRA ...

- Joint meetings & to establish protocol
 - Most appropriate regulator
- Common functions
 - Advertising, false and misleading, claims about therapeutic benefit
 - Use of botox, teeth whitening, pricing in pharmaceuticals
