#### FEBRUARY 2006 PROSTHESES LIST

### **Purpose**

The purposes of this Circular are to inform the health industry that:

- The delegate of the Minister for Health and Ageing has made a determination giving effect to a new version of the Prostheses List (February 2006); and
- The February 2006 Prostheses List commences on 14 March 2006.

## Variations from the previous Prostheses List – Part A

The February 2006 Prostheses List (Part A) contains the following changes:

- 210 products have been deleted at the request of the supplier (Attachment 3).
- 410 new products have been added; and
- Approximately 700 products have been changed at the request of the supplier (Attachment 4)

### Variations from the previous Prostheses List – Part B (Human Tissues)

The February Prostheses List (Part B) contains the following changes:

- 4 new human tissues have been added:
- 10 human tissues have been deleted at the request of the supplier (Attachment 5); and
- 26 human tissues have been changed at the request of the supplier. (Attachment 6).

### **Gap permitted products**

A list of the gap permitted products is set out at Attachment 7.

## Corrections

Suppliers are asked to carefully check the listing of their new products and changes requested to previous listings, and report any errors to the PDC Secretariat as soon as possible. Advice of errors should be emailed to <a href="mailto:Prostheses@health.gov.au">Prostheses@health.gov.au</a> by no later than Tuesday 14 March 2006.

Any errors will be corrected in an amending determination that will be released on 1 April 2006 and will take effect from 15 April 2006.

## Standard Freight and Loan Kit Costs

It should be noted that the cost of standard freight and loan kits is included in the benefits amounts for the following products:

- products that have been evaluated and grouped by Clinical Advisory Groups (ie cardiac stents, cardiac pacemakers and leads, cardiac defibrillators and leads, hip replacements, knee replacements and intraocular lenses);
- · new products listed in February 2005;
- · new products listed in August 2005; and
- new products listed in February 2006.

A field has been added to the Prostheses Database labelled "Freight/Loan Kit Fees Incl" to identify these products. If this field is checked, the cost of freight and loan kits has been included in the benefit amount/s for the product.

If this field is not checked, hospitals and health funds will need to check with the supplier whether the cost of freight or loan kits is included in the benefit amount/s.

The field is visible in "Tables" and "Forms" views of the database.

Over time, as new products are added to the Prostheses List and benefit amounts for grandfathered products are negotiated, every product on the List will have freight and loan kit fees included in the benefit amount/s. Once that occurs, the field will be removed from the database.

# **Choice of product**

The clinical choice of which product to use remains a matter between the doctor and the patient and it is not to be influenced by the manufacturer, supplier or health fund.
