Introduction

PHA welcomes the opportunity to provide advice on pricing for cardiac implantable electronic devices (CIEDs) and the associated technical support services.

The task for the Department of Health and Aged Care is twofold:

- 1. to deliver the promised savings to consumers consistent with the Memorandum of Understanding (MoU) between the previous Minister for Health, the Hon Greg Hunt, and the Medical Technology Association of Australia (MTAA), and
- 2. transition to a more appropriate method to fund support services, at a cost to consumers consistent with the advice from MSAC (1724).

The Memorandum of Understanding between the former Health Minister, Greg Hunt, and the MTAA, was seriously flawed, as noted by the Department of Health and Aged Care:

"in the view of the Department, [the MoU] predominantly benefitted industry rather than
providing a negotiated balance of benefits to industry and the Australian
community/government" (FoI 4046)

It is extremely disappointing that changes to the MoU since it's signing have further disadvantaged consumers.

The MoU required changes to CIED pricing to be finalised by June 2023. This did not occur, in part due to cardiac companies failing to provide information to MSAC as required by the MoU. The department has therefore only implemented partial pricing changes. To date, these delays have cost consumers more than \$100 million in projected savings. Every additional week of delay is costing consumers more than \$1 million.

Urgent action is required to protect consumers' interests. Anything less than reducing the prices in line with the MoU will be unacceptable to health funds' members. The Australian Government should also consider clawing back some of the savings already foregone.

PHA recommends:

- The cost of the medical devices be reduced as per the MoU to the public reference price plus 7-20%
 - Option: Set the device cost at the public reference price plus 20%, noting the implementation delay has already cost consumers over \$100 million in foregone savings.
 - Option: The government may also claw back some of the foregone savings by reducing the cost of the devices to the public reference price plus 7% (in line with other items on the Prescribed List (PL)).
- In the short term, the cost of the support services be shifted from a premium on the device to a new cardiac technical support services item on Part C on the PL.
 - This will require existing monitors and monitoring services to be removed from Part C, with the benefits incorporated into a new single cardiac monitoring benefit item.
- Over the medium term, the government should arrange for treating medical specialists to assign the Part C benefit rather than the sponsor, with the clinician then making arrangements for the patient to be monitored.

The pricing problem

CIEDs are vastly overpriced on the PL. Prior to the pricing cuts, CIEDs were up to two and half times the price in the public system. The Department noted:

"IHPA's analysis reveals that the public/private price gap for all cardiac devices is very large and price reductions for these devices will be key to achieving overall PL savings. For instance, for the most popular implanted defibrillator the PL benefit is around \$36,500 and the public price is around \$14,500." (Fol 4045)

The excessively high prices being charged for CIEDs must be addressed as a matter of urgency. During a cost-of-living crisis, consumers cannot afford to be financing the supernormal profits of multinational MedTech companies.

While the MoU provides a simple formula for reducing the prices of the devices, cardiac companies have argued there is a substantial cost to providing technical support services. The former Minister acquiesced and delayed the price cuts for CIEDs to allow MSAC to determine the true costs of providing technical support services.

The MoU notes:

"MTAA will take all reasonable steps to ensure that cardiac companies that produce CIEDs commit to engage with MSAC (expected no later than March 2022) and provide MSAC during its deliberations described in section 2.4.1 with company data relevant to the MSAC process."

MSAC has determined that the reasonable cost to consumers of the technical support services is \$44.4 million (based on 2021 data). However, Table 2 in MSAC 1724 highlights that the sponsors

failed to provide the relevant data for MSAC to properly determine the costs per device. In a further attempt to delay price cuts, sponsors neglected to provide advice on how these funds should be distributed. Therefore, it is now up to government to determine a fair approach to ensure consumers pay no more than the recommended \$44.4 million for the technical support services.

Recommended device pricing

The MoU includes a simple formula for device pricing. As per the MSAC advice, PHA recommends that the devices be priced separately to the services. This would allow for each device to be priced at the public reference price, plus 7-20%.

Disappointingly, the department has failed to provide the public reference prices, so PHA has sought to estimate the public reference prices based on the already published reductions (see attachment).

It makes no sense that privately insured consumers are being forced to pay 20% more than the public reference price. The vast majority of items on the PL have a premium of 7%, and the MoU provides no advice as to what consumers receive in exchange for this additional premium.

As CIED sponsors have secured an additional 15 months of higher prices – and have failed to provide the required data to MSAC – PHA recommends the government reduces the private premium from 20% to 7%. Sponsors would still receive more revenue from the delays to price cuts in 2023 and 2024 than they would lose from the premium reduction, thus meeting the terms of the MoU.

The attachment includes the public reference price estimates, and based on these estimates, recommended pricing with a 7% and a 20% premium.

Recommended technical support pricing

PHA recognises the importance of technical support services for CIEDs, although we note not all patients currently receive these services. The extraordinary high prices for CIEDs paid by private patients includes technical support services, yet patients are currently required to pay twice with cardiac monitors and monitoring services also appearing on Part C of the PL.

MSAC has determined that the technical support services are worth \$44.4 million per annum (based on 2021 volumes). Consumers are currently paying more than double this amount.

Prices should be reduced immediately. The MoU makes no provision for a phased reduction. Given the supernormal profits that CIED sponsors have enjoyed for many years at the expense of Australian consumers, there is no justification for further delays.

To meet the MSAC recommendation that technical support services be separated from the device costs on the PL, PHA recommends that the payment for technical support services be contained in Part C of the PL.

The simplest approach in the short term is to divide the funding available (\$44.4 million) by the number of devices funded through the PL (approximately 18,000). This provides a Part C payment for up to ten years' monitoring of approximately \$2500 for all CIEDs other than loop recorders.

To avoid consumers paying twice for the same service, existing Part C rebates for cardiac monitors and monitoring services should immediately cease. All monitoring services, software and/or hardware should be contained in the one payment.

The new monitoring payment should be claimable once per patient per device. It should not be able to be reclaimed for the same patient within a five-year period (to ensure consumers are not double paying where there is a revision surgery). All monitoring and technical support services should be included within this payment, with a condition that patients do not incur any out of pocket costs.

PHA recommends that within a 12-month period, the rebate be assigned by the treating clinician, rather than be automatically directed to the device company. The treating clinician could then decide who should be responsible for ongoing monitoring. Options should include the doctors' practice, the device company, or independent cardiac monitoring services. Staff providing services should be accredited by CSANZ or PICSA.

Separating the technical support services payment would also allow for further discussions on the best way to administer the payment, either through a lump sum, or converting it to an annual payment, conditional on the monitoring actually occurring. This work should be led by CSANZ and PICSA, and informed by PHA (representing consumers' interests) and the device industry.

Conclusion

Health funds have pledged to return any net savings from medical device funding reform to patients, either through reducing premium growth or increasing rebates for services to hospitals and medical practitioners. To date, medical device pricing reform has not delivered the anticipated savings.

The proposed pricing changes for CIEDs were due to deliver around one third of the savings for consumers, due to the very high prices paid to international MedTech companies. Unfortunately, the delays in pricing cuts have meant medical device funding reforms have not delivered as expected for consumers. During a cost-of-living crisis, and with pressure on many parts of the private health system, it is important for the government to take immediate steps to reduce the prices of CIEDs, while also providing a platform for ongoing reform to ensure technical support services are delivered under the supervision of treating medical practitioners.
